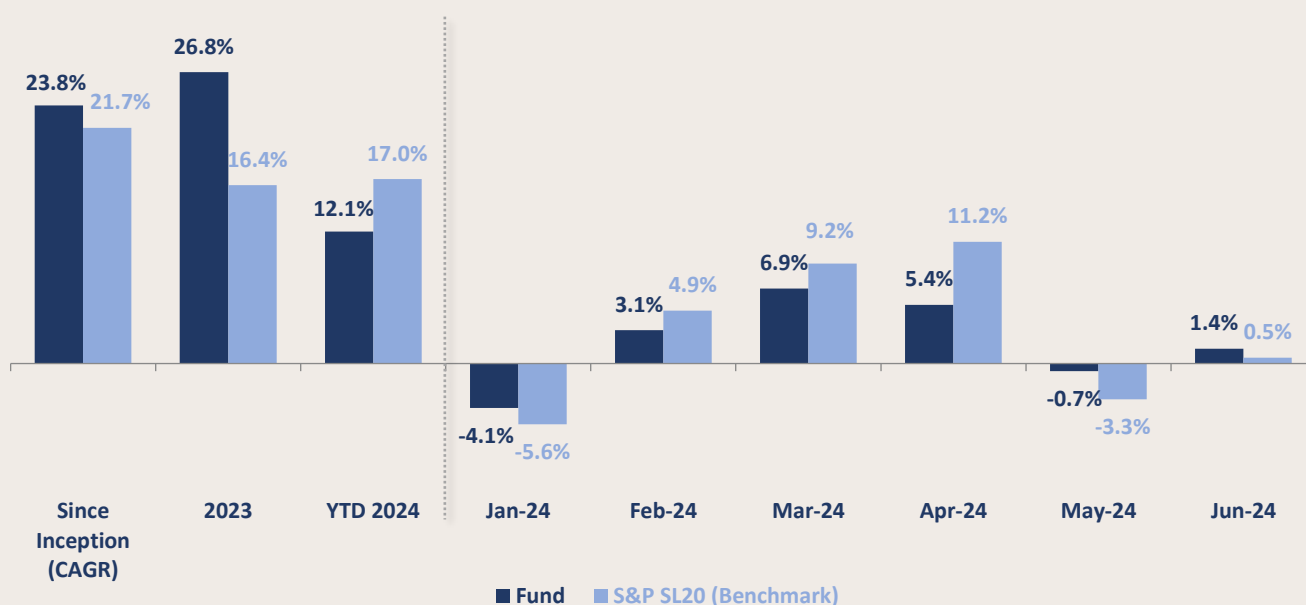
Details of the Fund

Investment Objective: Maximize risk adjusted returns on a medium to long term basis by investing in a portfolio of listed equity securities & fixed income securities.

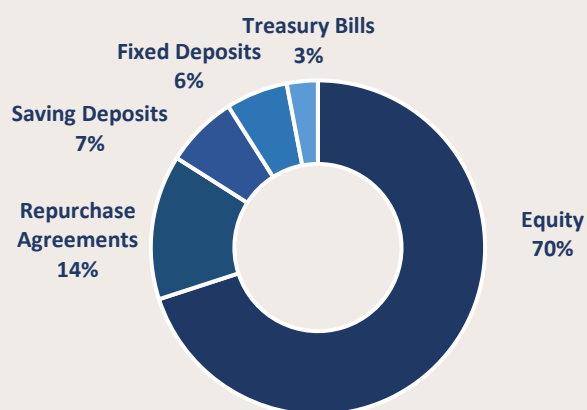
Who it's for: Investors with a moderate to high-risk appetite with the need for long term capital appreciation.

Investment / Withdrawal: Any Time. A notice period of 10 business days may be required prior to redemptions amounting to 3% or more of the NAV of the Fund.

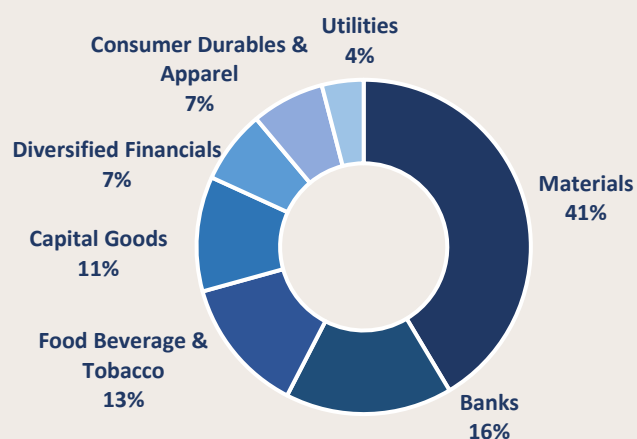
Performance History



Asset Allocation* (As a % of NAV)

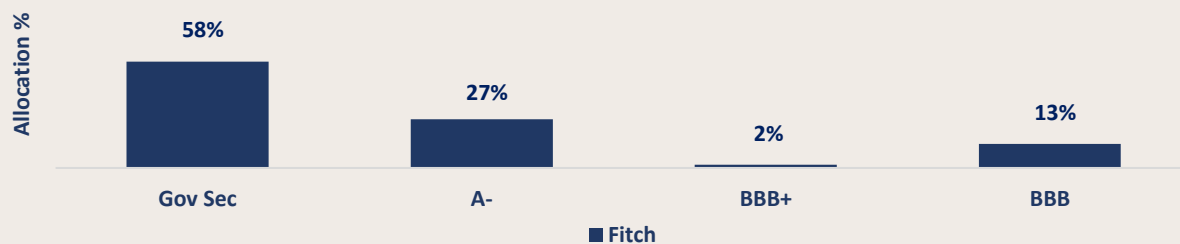


Sector Allocation (Within Equity)
