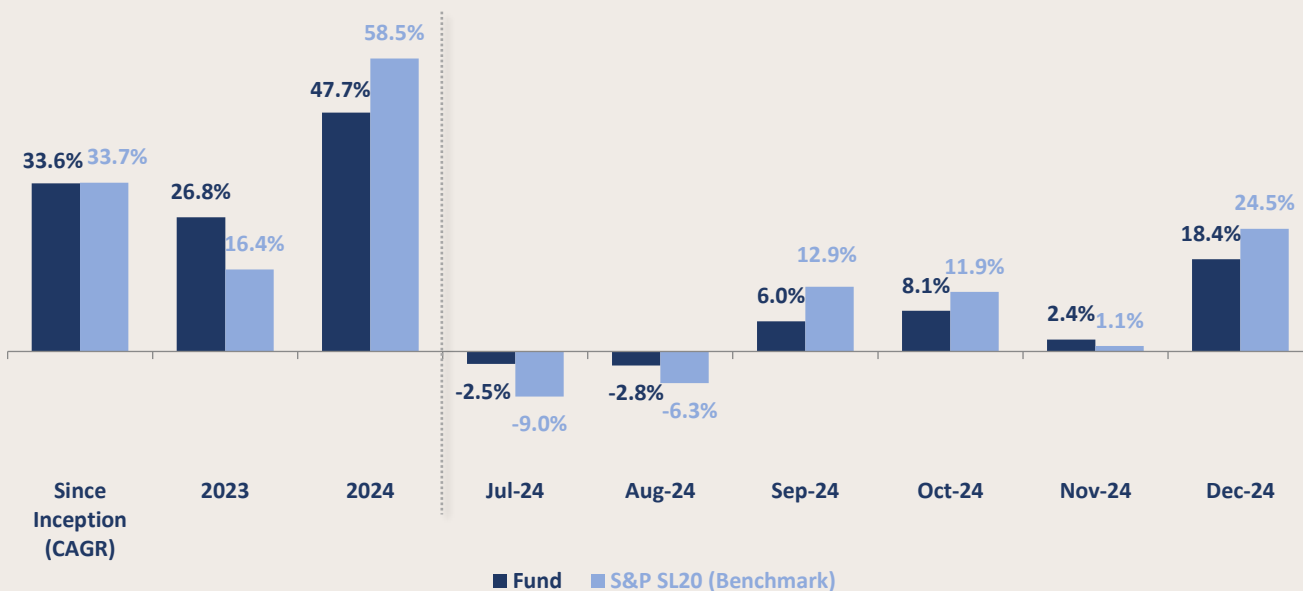
Details of the Fund

Investment Objective: Maximize risk adjusted returns on a medium to long term basis by investing in a portfolio of listed equity securities & fixed income securities.

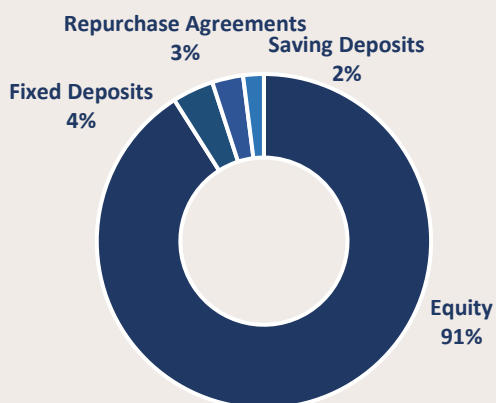
Who it's for: Investors with a moderate to high-risk appetite with the need for long-term capital appreciation.

Investment / Withdrawal: Any Time. Exit fee applicable for any redemption within 365 from the date of issue of Units.

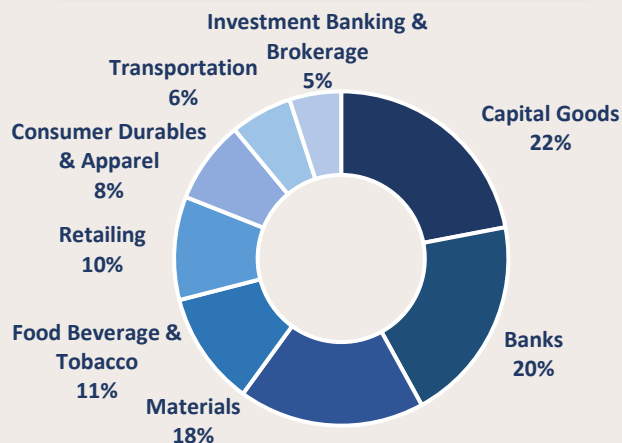
Performance History



Asset Allocation* (As a % of NAV)

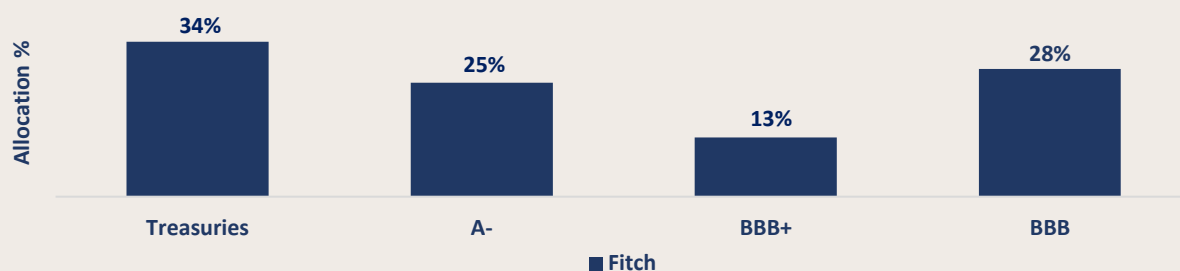


Sector Allocation (Within Equity)
