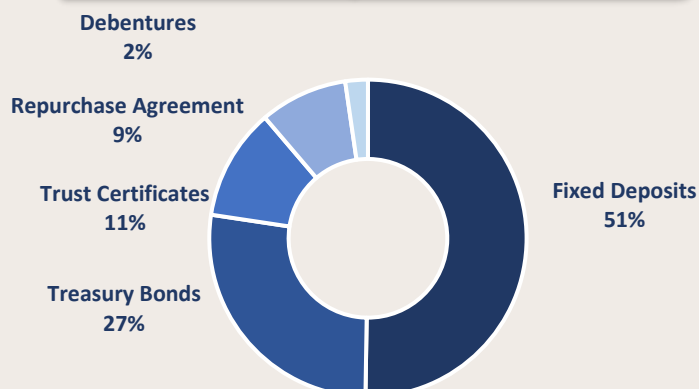

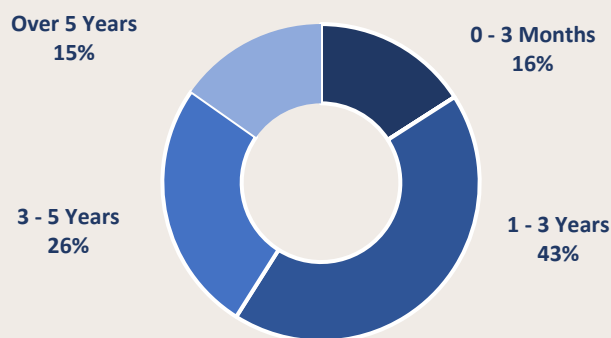

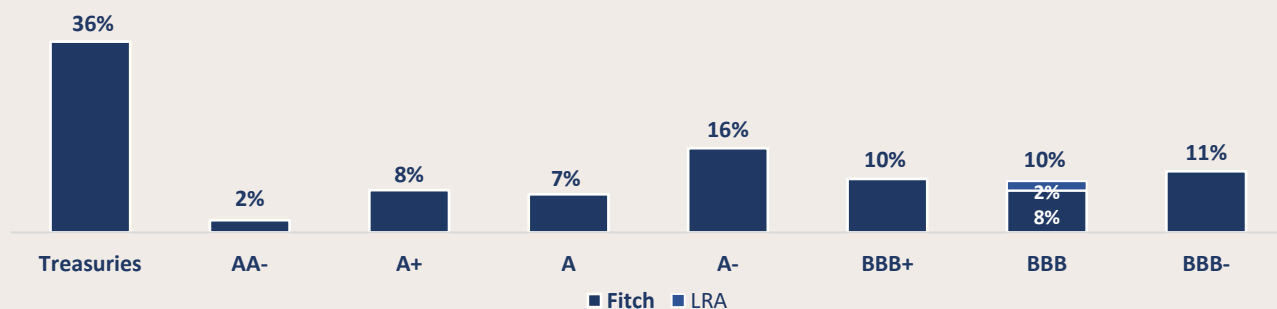
Security Allocation
